Tournament Purpose

Milwaukee Chapter of Muskies Inc is pleased to announce their Fall Fishing Tournament on Pewaukee Lake. This is a payout/fundraising tournament. The purpose of this tournament is to attract new members and raise funds for club programs. This includes but not limited to muskie rearing and stocking efforts for area lakes, monthly membership meetings with guest speakers, youth outings, and veterans' memorial outings.

Tournament Rules

1. Mandatory sign-in and rules meeting for all contestants begins at 6:30a.m. at Smokey's Muskie Shop.
2. Contestants must complete release of liability forms prior to the event.
3. All contestants will fish in accordance with current Wisconsin State and local Fishing and Boating Regulations.
4. Fishing hours are 7 a.m. to 4 p.m.
5. All Juniors must be accompanied by an adult.
6. No alcoholic beverages allowed during fishing hours.
7. A maximum of two anglers per boat allowed. Entrants per boat fishes toward a team score.
8. All occupants of your boat must be registered, paid contestants. If a guide is hired, he/she must be a paid contestant.
9. One line per person. **CASTING ARTIFICIAL LURES ONLY. NO LIVE BAIT.**
10. Motor trolling is restricted to anglers with physical disabilities with prior approval from

the tournament committee

11. Only judge boat verifications with tournament approved bump boards qualify.
12. The point system to determine winners will be as follows:
 - Must be a minimum of 34" to score.
 - Ten points for 34" minimum
 - An additional point per inch over minimum, measured to the nearest half inch.
13. Tournament officials may inspect contestants' boats at any time.
14. The decision of the tournament committee is final.
15. Muskies Inc., the Milwaukee Chapter of Muskies, Inc., its officers and board members are not responsible for any injuries, damages or loss incurred while participating in this event.
16. No points will be given for a fish that is not successfully released.
17. This is a team event, so any angler wishing to fish alone, must pay two entry fees.
